

# Terms and Conditions

## **Agreement between User and myheartcheck.org**

Welcome to myheartcheck.org. The myheartcheck.org website (the "Site") is comprised of various web pages operated by My-HeartCheck ("MHC"). myheartcheck.org is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of myheartcheck.org constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

myheartcheck.org is an E-Commerce Site.

This site provides educational resources and scheduling for preventative heart screenings, intended for kids ages 8 to 25.

MHC collects personally identifiable information from children under the age of thirteen. MHC collects this information for the following reason(s):

Personal information collected is limited to; full name, gender, and date of birth. This information is used strictly for the purpose of providing accurate test results.

We provide information about our personal data practices for children on our home page and wherever we knowingly collect personal data from children on our Web site. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website. If you are a parent and you have questions regarding our data collection practices, please contact us using the information provided at the end of this Agreement. If you are under 18, you may use myheartcheck.org only with permission of a parent or guardian.

## **Cancellation/Refund Policy**

A full refund for cancellations will be honored if written notice is received at least 5 days prior to your scheduled event. MHC reserves the right to cancel a screening event in the unlikely event of insufficient enrolment or other unforeseen circumstances. If an event is canceled or postponed, MHC will provide full refunds for registration fees but cannot be held responsible for other costs or expenses.
